Minnesota Statutes section 10A.022, subdivision 3, describes the procedures required for investigating complaints. A full description of the complaint process is available on the Board's website.

Briefly, the Board will notify you when it has received your complaint. The Board must send a copy of the complaint to the respondent. Complaints and investigations are confidential. Board members and staff cannot talk about an investigation except as required to carry out the investigation or to take action in the matter. After the Board issues a decision, the record of the investigation is public.

The law requires a complaint to go through two stages before the Board can begin an investigation: a prima facie determination and a probable cause decision. If the complaint does not pass one of the stages, it must be dismissed.

The Board has 10 business days after receiving your complaint to determine whether the complaint is sufficient to allege a prima facie violation of the campaign finance laws. If the Board determines that the complaint does allege a prima facie violation, the Board has 45 days to decide whether probable cause exists to believe a violation that warrants a formal investigation has occurred. Both you and the respondent have the right to be heard on the issue of probable cause before the Board makes this decision. The Board will notify you if the complaint moves to the probable cause stage.

If the Board determines that probable cause does not exist, the Board will dismiss the complaint. If the Board determines that probable cause exists, the Board will start an investigation. The Board will send you monthly updates regarding the status of the investigation. At the end of the investigation, the Board will offer you and the respondent the opportunity to be heard before the Board makes a final decision.

In most cases, the Board will issue findings, conclusions, and an order as its decision. For a spending or contribution limits violation, the Board can enter into a conciliation agreement with the respondent instead of issuing findings, conclusions, and an order. The Board's final decision will be sent to you and posted on the Board's website.

Complaint Facts:

- Minnesota Everytown for Gun Safety Victory Fund is an Independent Expenditure Committee organized under Minnesota Law.
- Erin Maye Quade is a candidate for the office of State Representative. Her committee, Minnesotans for Erin Maye Quade, is a candidate committee organized under Minnesota Law.
- Alyse Maye Quade is the MN State Organizing Director for Everytown for Gun Safety, a 501c4 that is affiliated with Minnesota Everytown for Gun Safety Victory Fund. Alyse Maye Quade is also the spouse of Erin Maye Quade (see exhibits 1 and 2).
- Moms Demand Action is an activist organization that merged into Everytown for Gun Safety in December 2013 (see exhibit 3).
- On October 31st, Alyse Maye Quade sent an email to activists in Minnesota using the email address amayequade@everytown.org with the subject line "ICYMI: Moms Demand Action Getting Out the Vote!" (see exhibit 4).
- In the email, Alyse Maye Quade called for activists to join with Everytown and Moms Demand Action to make calls and door knock for "gun sense candidates" (see exhibit 4).
- Everytown has on several occasions made references to Erin Maye Quade as a "gun sense candidate".
- As of the October 31st Campaign Finance Reports, Minnesota Everytown for Gun Safety Victory Fund has spent several thousand dollars of staff time from its parent organizations, including Alyse Maye Quade's employer (see most recent CFB filing).

Allegations:

- Everytown, though Alyse Maye Quade, the spouse of Erin Maye Quade, is illegally coordinating with Ms. Quade's campaign committee in violation of MN Statute 10A.121, MN 10A.15, MN 10A.17, and MN 10A.01.
- Specifically, Everytown's expenditures and staff time being used to support "gun sense candidates" is directly benefiting Ms. Quade's campaign. Ms. Alyse Maye Quade's involvement as State Organizing Director means that any actions being taken in Minnesota by Everytown and its affiliates is being improperly and illegally coordinated with Ms. Quade's campaign.
- As an employee of Everytown, Alyse Maye Quade would have non-public intimate information regarding the development, targeting, and deployment of campaign assets and internal strategies and expenditures used to support "gun sense" candidates throughout Minnesota, including her spouse, Erin Maye Quade.
- Advisory Opinion 410 of the Minnesota Campaign Finance Board contains a similar finding regarding the use of a vendor by both a campaign and an independent expenditure committee. Ms. Alyse Maye Quade is in an similar situation as the vendor in AO 410, when the board wrote "The board believes that it is not possible for a single individual to avoid coordination of effort between the two clients..." as the spouse of candidate Erin Maye Quade, it is impossible for her to separate and avoid coordination of efforts between her spouse's campaign and the campaign efforts of her employer in support of her spouse.
